OVERVIEW

This document describes DTC's DWCEOD function, used for transmission DWAC instructions via CCF/DTF DTC's Data Transmission Facilities.

THE DWCEOD FUNCTION

DTC creates this file daily.

Participants submit Deposit/Withdrawal instructions via online PTS functions PDWC and NDWC. These instructions must be approved/cancelled by the custodian.

The DWCEOD function will provide Participants with information pertaining to the disposition of their DWAC instructions. These DWAC instructions initiated by Participants were either 'confirmed' or 'rejected' by the authorized Transfer Agents (TA).

Availability of DWCEOD

The DWCEOD will generally be available at 6:30 P.M. the next business day.

Holiday Processing

- All Closed - Banks, Exchange and DTC closed: (New Year's Day, Presidents Day, Memorial Day, July 4th, Labor Day, Thanksgiving Day, and Christmas Day) - *None*
- Banks Closed, Exchange Open and DTC Open (Columbus Day, Veterans Day) - *Will be processed*
- Banks Open, DTC Open, Exchange Closed (Good Friday) - *None*
- Exchange Open, Banks and DTC Closed (Martin Luther King Day) - *None*

DWCEOD RECORD FORMATS

The record layout for the DWAC/STS Participant Acknowledgment Facility is defined below. This record contains a transaction header and application detail data and has a record length of 526. The DTF header is prefixed to every application record.

The DTF Header Record

The field layout of the 26-byte header is defined as:

Position	Length	Format	Field Name	DWAC DTF Record Description
1	1	Character	Message Type Indicator	Indicates an output message. This field is to be left blank on input.
2	1	Character	Test/Production Indicator	Indicates if the transaction is to be processed in the Test or Production environment. This is a required field. Values are: T = Test / P = Production Must be "P" for all DTF messages.
3	6	Character	Record Type	Value = "DWCEOD"
9	2	Numeric	Record Suffix	Indicates the Record # on single and multiple Data Records within a transaction.
11	2	Numeric	Version Number	Indicates the version (e.g., latest or previous format) the data is in.
13	6	Character	User Reference Number	Used by the transmitting party to uniquely identify the transaction (optional).
19	8	Character	Addressee	The entity on behalf of which the transaction is being processed: Participant number full numeric addressees.
