MA/NA Position Transfer allows you to make same-day position transfers from your Minimum Amount (MA) account to your Net Additions (NA) account and vice-versa. Day Transfer Position results in same-day position transfers. Night Transfer Position results in same-day night cycle position transfers.

Key: **M** = Mandatory, **O** = Optional
