ISO Message Type: **MT543 - Deliver Against Payment**

A securities payment order (SPO) is used to collect a mark-to-market payment based on the difference between the current and previous market value of an open securities contract. The SPO transmission authorizes DTC to credit the payee participant's settlement account with the specified amount and to debit the payor participant's settlement account for the same amount.
